IP LICENCE AGREEMENT

PART C | GRANT OF LICENCE TO LICENSEE

4 SCOPE OF LICENCE TO LICENSEE

- 4.1. Subject to Clause 4.2, and in consideration of the Licence Fees set out in Schedule 2 (Licence Fees), the Licensor hereby grants (or shall procure the granting) to Licensee the following during the Term:
 - 4.1.1. a licence to use the Operational IPR;
 - 4.1.2. a licence to use the Promotional IPR in connection with the promotion of the Business Activity; and
 - 4.1.3. such rights as are set out in Schedule 5 (Other IPR) in relation to the Other IPR.
- 4.2. Licensee acknowledges and agrees that the Licensor grants the rights under Clause 4.1 strictly subject to the following terms and conditions:
 - 4.2.1. the grant of licence shall be on an exclusive and non-transferable basis;
 - 4.2.2. the grant of licence is limited solely for the Authorised Purposes in connection with the Business Activity in the Country; and
 - 4.2.3. Licensee's use of the Group IPR is subject to the special terms and conditions governing each category of IPR as set out in Schedule 3 (Operational HR), Schedule 4 (Promotional IPR) and Schedule 5 (Other IPR).
- 4.3. No further right or licence is granted by the Licensor to Licensee by this Agreement and the Licensor reserves all rights not specifically granted to Licensee, including all rights beyond the Term.
